**HOLD HARMLESS AGREEMENT/RELEASE**

This form shall be utilized by all people who either

- work for the Borough of Merchantville as counselors for the Parks and Recreation Program,
- or
- who have children attending the Borough of Merchantville Parks and Recreation Program

**WHEREAS**, the Borough of Merchantville (“Merchantville”), with an address of 1 West Maple Avenue, Merchantville, New Jersey, is the owner of Merchantville Community Center, located within the Borough of Merchantville; and

**WHEREAS**, some individuals have agreed to work /attend the Parks and Recreation Program; and

**WHEREAS**, the Borough of Merchantville requires each counselor and attendee to agree to the following conditions in order to work or attend the Parks and Recreation Program:

- A. **RELEASE AND HOLD HARMLESS:** Counselors and attendees do hereby release the Borough of Merchantville, its officers, agents, or employees, from and all liability arising from (i) the operation, conduct or management of or from any work or thing whatsoever done in or about the Recreation Center, including, but not limited to, any building, structure, equipment or improvement now or hereafter erected or placed at the Recreation Center, (ii) any condition of any sidewalk, alley, open field or area, or driveway within or adjacent to the Recreation Center, the buildings at the Recreation Center or of any other structure or improvement now or hereafter erected over, under or upon the Recreation Center or used in connection therewith, and (iii) any act or omission of the Borough of Merchantville, its officers, agents, servants or employees unless such act or omission shall constitute gross or willful negligence.

This release discharges Merchantville from any liability or claim that the Counselors or attendees may have against Merchantville with respect to any claims, suits, actions, damages, judgments, liabilities, fines, penalties, costs and expenses for loss of life, personal injury or damage to property. This Release is complete whether the claim is due to the negligence of Merchantville or is based on any other legal or other theory whatsoever.

- B. **INSURANCE:** Merchantville may not carry a policy of insurance for the benefit of the counselor/attendee. If a loss of any nature shall occur, the Counselor/attendee agrees and understands that Merchantville shall not be responsible in any way.
- C. **RESPONSIBILITY OF MERCHANTVILLE:** Merchantville shall have no responsibility to the Counselor/attendee other than to provide access to the Recreation Center. This shall include the use of materials, equipment and labor.
